



## Ann Crouch

March 3, 1934 - February 6, 2016

Ann Shelton Reid Crouch, age 81 of 210 Withers Circle, Danville, VA, died on Saturday, February 6, 2016 at her residence after a decline in health for the past three months.

She was born in Ringgold, VA, on March 3, 1934, a daughter of the late Willie Bennett Crouch and Mattie Esther Hutcherson Crouch. She lived most of her life in Danville, VA where she worked at Dan River Mills as a clerk in the cloth store until her retirement after 31 years.

On April 3, 1982 she married Albert Crouch who survives. Mrs. Crouch was a member of Schoolfield Baptist Church.
