



## Camilla Stuck Law

March 8, 1937 - December 24, 2025

Camilla Stuck Law, age 88, of Raleigh, NC, passed away peacefully on December 24th, 2025. She was born in Burlington, NC, on March 8th, 1937, to the late Fred Lea and Mary Sue Hicks Stuck.

She is survived by her daughter, Susan Amygayle (James) Womble of Raleigh, NC, and sons, Charles James (Catherine) Law, III, of Williamsburg, VA, and Christopher Jerel (Liz) Law of Huntersville, NC.
