Lois Jeannette Fugate Laws, 81, of 151 Sunset Place, Danville, VA, died Sunday, May 8, 2022 at her residence after a decline in her health since 1996.

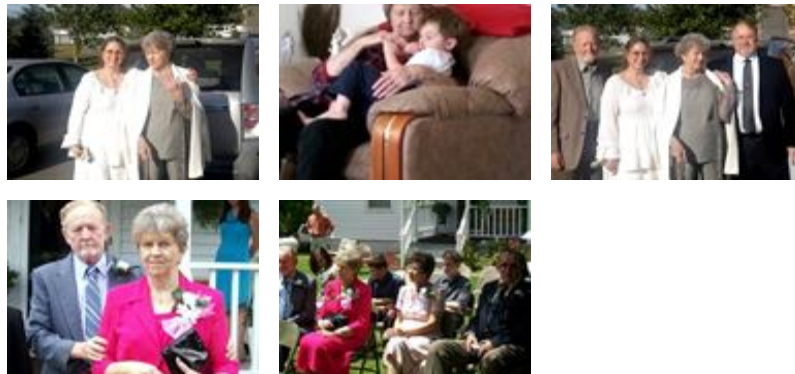
